## Additional Terms (Force Majeure and Termination):

(a) Force majeure means an event that is not externally related and cannot be expected even by the utmost reasonable care. These include, in particular, natural disasters of all kinds, in particular earthquakes, floods, storms, volcanic eruptions, but also of low-level coincidences such as riots, blockades, fires, civil wars, embargoes, earthquakes, hostage-taking, war, revolution, sabotage and terrorism. Also considered as force majeure are cases in which the event becomes impossible to conduct for either party or is prohibited or a cancellation is advised due to official order, as long as the affected Party is not responsible for this or cannot avert it. The respective party will immediately inform the other party in writing of this circumstance. (b) Should the provision of services be permanently restricted or unreasonable for a party due to Force Majeure, that party will have the right to withdraw from the contract. In this case, all (pre-) payments already made will be reimbursed. There are no claims for damages or any other liability.
